Textbook Adoption Publisher Assurances

House Enrolled Act 1429 was passed by the Indiana General Assembly during the 117th General Session. HEA 1429 outlines the review process and the assurances required by publishers in order for their curricular materials to be reviewed. Please see the detailed information below that will govern the review process.

- IC 20-20-5.5-2(a) states that the department staff shall evaluate curricular materials. The evaluation must include an evaluation of: the curricular materials' alignment to the academic standards adopted by the state board under IC 20-31-3-1; and the appropriateness of the reading level of the curricular materials.
- IC 20-20-5.5-2(b) states that the department shall publish a report that describes the method used to conduct the evaluation required under subsection (a) and that contains the results of the evaluation. The report must: provide a list of each curricular material evaluated and a summary of the evaluation for each curricular material; be updated annually; and provide a listing and summary review for the curricular materials that are aligned to the academic standards adopted by the state board under IC 20-31-3-1 for English/Language Arts; Reading; Mathematics; Science; Social Studies; Miscellaneous; and World Languages.
- IC 20-20-5.5-2(d) states that in order to be included in the report under subsection (b), a publisher must provide the department a written exact and standard statewide price for each curricular material.
