SUBJECT: Reimbursement for 2015 Summer School Programs

DATE: November 18, 2015

The Department has finalized the computation for reimbursement based on the 2015 summer school reports submitted.

Category 1 programs (core curricular programs in the elementary and middle school grades and classes required for graduation at the high school level) will be reimbursed at 100% of eligible costs. "Eligible costs" equal 105% of instructional salaries as reported on your Summer School Final Report.

Because there were funds available after reimbursement of Category 1 programs, the Department reimbursed a portion of Category 2 costs with no reimbursement for Category 3 programs at 100%. Attached to this notice is a list of reimbursement payments by school corporation and charter schools. The payment for 2015 summer school programs will occur on November 20.
