**SUBJECT:** Reimbursement for 2016 Summer School Programs

**DATE:** November 14, 2016

The Department has finalized the computation for reimbursement of summer school costs based on the 2016 summer school final reports that were submitted by eligible school corporations and charter schools.

The total costs submitted on the final costs report for all eligible schools was more than \$19.9 million. The appropriation was not sufficient to reimburse costs at 105%, all submissions were reduced proportionately. The reimbursement rate for 2016 summer school is approximately 92.03%. Attached to this notice is a list of reimbursement payments by school corporation and charter schools. The payment for 2016 summer School programs will occur on November 17, 2016.
