

MEDICAID REIMBURSEMENTS FOR IEP SERVICES

Annual Statewide Total # Claiming

Total Medicaid reimbursement (state & federal \$) for IEP-required service goes to the LEA. IDOE adjusts the participating LEA's monthly tuition support by the amount of state \$ + 3% of the federal \$ already received in the Medicaid payment. [Per IC 12-15-1-16, the State retains 3% of the federal \$ to defray state program administration costs.] The Medicaid-participating LEA restores the state \$ to tuition support and uses the remaining unrestricted federal \$ (approximately 67% of total reimbursement) as it chooses, e.g., for supplies, training, equipment or professional development.
