

## Purpose

The purpose of this data collection is to gather information on Title I services a student received or was eligible to receive throughout the 2014-2015 school year. Count those students served or eligible to receive Title I services during the fall of 2014, spring of 2015 and summer of 2015 in the Title I funded schools. This information is used for federal and state reporting.

## Audience

This is a required collection for:

- ✓ Public school corporations. (Nonpublic schools and neglected institutions that receive Title I services should cooperate with their local public school corporation to provide these data. It is the responsibility of the Public School Corporation (LEA) to report the data for public, nonpublic schools, and neglected institutions that receive or provide services.)
- ✓ Charter schools

## Collection Year: 2014-2015

## Instructions

**Please note: This data collection no longer includes data fields for School Choice and Supplemental Educational Services (SES).**

This is a required collection for public schools, charter schools, nonpublic schools and neglected institutions that receive Title I services. However, it is the responsibility of the Public School Corporation (LEA) to report the data for public, nonpublic schools, and neglected institutions that receive or provide services through the corporation.

The required data should be collected, combined into a file and submitted to the Department of Education via the STN Application Center. Please note: This is different from the Online Title I Application Center and requires a different login. The file must contain all the fields in the order described and must contain the data required for each field. The file may be in any of the formats contained in this document.

This collection should include all Title I-eligible students. (Eligible students are defined as (a) those who are failing or most at risk of not meeting state student-performance standards in a Title I targeted assistance program or (b) any student in a Title I school wide program.) Report those students served by Title I funding at any time during the 2014-2015 school year. (No additional ARRA funding was provided during 2014-2015, so these services will no longer be reported in this collection.)

The required collection and signoff periods will run concurrently. The **required collection/signoff period** begins **July 6, 2015**, and ends **September 18, 2015, which is the due date for this collection.**

(**Late submissions** will be accepted from September 19 through September 30, which is the **final** date for late submission. The submission of late data after the September 18 due date will require a written explanation and plan of correction **from your Superintendent** as a noncompliant corporation and your corporation will also be reported to the Office of Accreditation as *out of compliance with Legal Standard 5, Timely Submission of Reports.*)

During the collection window, you are required to submit a file, review the processing results of the file for errors, and review the reports found under Data Verification for accuracy. These reports are provided for you under Data Verification > Reports > Title I and should be printed and reviewed by the responsible person(s). If there are any errors or inaccuracies you may correct your data file and resubmit until the end of the day of on September 18th.

Only online signoff will be required. (Paper signoff is not required.)

**Reporting Results:** School B reports this student once for Title I services. School C reports this student once for Title I services. School D does NOT count this student. If a student received Title I services for a reasonable period of time (at least one grade period or completion of program during the year, such as a summer program, or another extended-time opportunity), the student is reported as having received Title I services.

**Scenario #2: Support Services**

Scenario: A student receives support services but the support services are not paid by Title I funds.

**Reporting Results:** In a school wide program the Title I students are reported as Y (Yes) for the support service they receive. In a targeted assistance Title I school, only report Title I funded services for targeted Title I students.

**Scenario for Determining Whether to Report Students**

**Scenario #3: Completion of a program, less than 15 days**

Scenario: A student is enrolled in a school or facility for 12 days. During this time, the student completed a 10-day after school program funded by Title I.

**Reporting Results:** While the student was not enrolled in the program for at least 15 consecutive days, the student did complete an extended time program and should be counted as receiving Title I services.

**Scenario #4: Participation in a program for at least 15 non-consecutive days at a targeted assistance school**

Scenario: A student is enrolled in a school or facility for 5 days, then leaves. Two months later, the student returns to the same institution for 11 days.

**Reporting Results:** Because the student did not complete an extended time program and was not enrolled in the school or facility for at least 15 consecutive school days, the Title I services should not be reported by this institution. However, the student should be submitted as ESEA Title I Program Code 5 (eligible for TI Part A but not served).

**Scenario #5: Participation in a program, did not complete**

Scenario: A student is enrolled in an institution in the middle of a two-week summer program funded by Title I. The student completed four days of the summer program, but then left the program.

**Reporting Results:** Because the student did not complete the entire duration of the summer program and was not enrolled in the program for at least 15 consecutive school days, the Title I services should not be reported by this institution. However, the student should be submitted as ESEA Title I Program Code 5 (eligible for TI Part A but not served).

## Frequently Asked Questions

### REPORTING REQUIREMENTS

1. **Q. Which corporations should submit the Title I data collection (DOE-TI)?**
  - A. The DOE-TI is a required collection for any public school corporation and charter school that has public schools, nonpublic schools, and neglected institutions to which it channels Title I funding or provides Title I services. Public school corporations are responsible for reporting for the schools and neglected institutions listed in Collection Management in the Application Center.
2. **Q. My school corporation is a public school corporation but the name of a neglected institution appears on my DOE-TI report. Why does this residential facility for neglected students appear in Collection Management?**
  - A. The neglected institution was included in your corporation's Title I application as a facility to be served with the Title I funding your corporation received. As such, if the neglected institution served students using Title I funds, then data for the neglected institution must also be reported by your school corporation.
3. **Q. My school corporation is a public school corporation but the name of a nonpublic school appears on my DOE-TI report. Why does this nonpublic school appear in Collection Management?**
  - A. The nonpublic school is/was included in your corporation's Title I application as a facility to be served with the Title I funding your corporation received. As such, if the nonpublic school served students using Title I funds, then data for the nonpublic school must also be reported by your school corporation.

### OTHER SPECIFIC REPORTING QUESTIONS

1. **Q. What happened to the fields for School Choice and Supplemental Services?**
  - A. The DOE-TI collection no longer includes data fields for School Choice and Supplemental Educational Services. These fields applied only to schools in Improvement status and the feedback we received suggested that these fields made the

collection overly complicated. Our Title I Office will contact Public School Corporations (LEA) of schools in Improvement status with information on reporting these numbers apart from the DOE-TI.

2. **Q. Fields 9 and 10 ask for student information regarding guidance and health services. Is reporting this information against the rules of HIPAA?**
  - A. School-based health records are covered by FERPA and supersede the rules of HIPAA. Schools and IDOE are legally allowed to collect these data and may do so even without prior parental consent, pursuant to 34 CFR Sec. 99.31(a).
3. **Q. My school operates a school wide Title I program and all students are reported for Title I. Must a student have completed the instruction at this school during the grading period? How long must a student receive Title I services to be reported on the DOE-TI?**
  - A. Schools operating a school wide Title I program should report all students as having received Title I services regardless of the period of time that a student has received the services.  
This means that a school would have to code all of the students in a school wide building as having received the services. In completing the fields about instruction, a school would have to identify the services provided using Title I dollars and code each of the students in a school-wide building as having received those services. For instance, if in a school wide building of 150 students, Reading instruction was provided by Title I, all 150 students would be coded as having received Reading instruction.
4. **Q. In a situation where a Title I eligible student is provided services but the services are not paid by Title I funds, should these services be reported as "Yes" for the student?**
  - A. For a school wide Title I program, any Title I services provided for students should be reported as "Yes," even if Title I funds did not pay for the services. Examples of services not funded by Title I are support services such as home visitation, guidance, health, etc. For a targeted assistance Title I school, only report the Title I-funded services for Title I targeted students.

## TECH TIPS & TROUBLESHOOTING

1. **Q. One of the schools that appears on my school corporation's Title I report has no Title I students to report, but there is no checkbox in Collection Management to report "no records" for that school. How should this situation be handled?**
  - A. The "No Records" checkbox is not available for this collection. Each corporation is responsible for reporting students for ALL schools listed in Collection Management. These schools were identified by your school corporation's Title I Program Administrator as schools to be served with Title I funds. If, after reviewing the matter with your local Title I Program Administrator, you still believe that a school is listed in error, please contact Lenee Reedus of IDOE's Title I division at 317/232-0540 or [lreedus@doe.in.gov](mailto:lreedus@doe.in.gov).
2. **Q. Can you tell me where to locate the sign off page for the DOE-TI report?**
  - A. Districts are no longer required to sign and fax any pages in this data collection, however, you are required to check the sign off box under Data Verification > Collection Management > 2014-2015 Title I.

## How and Where are the Data Used

An administrative and money collection, DOE-TI gathers information regarding Title I services a student receives, or is eligible to receive, throughout the school year. The collection provides a detailed account of supplemental instruction, support services and extended time opportunities the student receives.
