

**Choice Scholarship Program  
Continuing Choice Pathway  
2018-2019 School Year**

**Student must satisfy all criteria to qualify for the Choice Scholarship Program under the Continuing Choice Pathway.**

1. A student must:
  - a. Have legal settlement in Indiana;
  - b. Be between the ages of 5 and 22 by August 1<sup>st</sup>; **AND**
  - c. Be accepted for enrollment into a participating Choice Scholarship school.
2. A student must:
  - a. Have received a Choice Scholarship in the school year that **immediately precedes the school year** for which the student is applying for a Choice Scholarship; **AND**
  - b. Have remained enrolled at a participating Choice Scholarship school for the entirety of the **immediately preceding school year**.

**AND**

3. A student must be a member of a household with an annual income equal to or below 200% of the amount to qualify for the Federal Reduced Lunch Program.

For a household size of eleven (11) or more, add \$7,992 to the annual limit for each additional member for a 90% scholarship and add \$15,984 to the annual limit for each additional member for a 50% scholarship.

90% and 50% Choice Scholarships are 90% and 50% of the public tuition support amount of a student's public school corporation of legal settlement. 90% and 50% award amounts can be found at [www.doe.in.gov/choice](http://www.doe.in.gov/choice) under Estimated Award Amounts by Corporation.
