\*The Council for the Accreditation of Educator Preparation (CAEP) will be initiating advanced-level program reviews for all EPPs beginning fall 2019. Advanced-level programs within an EPP were not expected to be included in the CAEP review process if the CAEP onsite visit was scheduled prior to fall 2019. EPPs, however, could opt to include advanced-level programs, but were not required to do so. In fall 2018, CAEP informed EPPs with advanced-level programs expiring in 2018 that in order to maintain advanced level accreditation they would be required to undergo a modified advanced-level program virtual review within two years of their site visit. Per consultation with CAEP and the IDOE, Indiana programs may choose whether or not to undergo an advanced-level virtual review; however, all these programs must undergo an advanced-level review as part of their next accreditation review cycle.
