Subject: Master List of Updated Grant Deadlines

Due to encumbrance and liquidation deadlines extended by the U.S. Department of Education for certain federal grants, and IDOE utilizing its authority for certain state grants, this memorandum serves as a master list of updated grant deadlines that LEAs may utilize to replace current award memoranda that have outdated deadlines.

LEAs should file this memorandum along with respective grants for record keeping purposes, including as justification for expenses that were encumbered or liquidated beyond original deadlines.
