

Criteria for Dyslexia Screeners

The Indiana Department of Education (IDOE) approved screeners for dyslexia require adherence to the Indiana Code 20-35.5, *et. seq.*, as created by SEA 217 (2018) criteria as well as scientific standards for assessments. The form below describes the criteria used by IDOE in approving screeners. Should a corporation or charter school wish to use a screener that is not approved by IDOE, it must complete the form below and describe how the screener meets the criteria listed below prior to approval by IDOE. These will be reviewed on a yearly basis.

Universal Screener

All six subsets are administered to all students in kindergarten, first, and second grade each academic year regardless of previous year's performance.
