IC 20-36-2 Chapter 2. Programs for High Ability Students State resources program; grants for high ability programs Sec. 1.(b) In addition to the program established under subsection (a), the department shall use appropriations to provide grants to school corporations for expenditures beyond those for regular educational programs and specific to programs for high ability students under section 2 of this chapter in an amount determined by the department that is based upon a set minimum amount increased by an additional amount for each student in the program.
