<b>March 27, 2020 – June 30, 2020</b>	Final report form is open. <b>Funds must be encumbered.</b>	All participating schools must complete a Final Report verifying use of grant funds. The Final Report Form will be provided to CTCs and additional contacts via the Formative (Interim) Assessment Grant listserv.
<b>July 31, 2020</b>	Any <b>unencumbered</b> funds must be returned to the Indiana Department of Education.	<b>Schools may not “roll-over” unused funds to the next year. 2019-2020 Formative Grant funds must be either used within the 2019-2020 school year or returned to the State. Unencumbered</b> funds reported in the Final Report Form must be returned via the directions published through the Formative (Interim) Assessment Grant listserv. These directions may also be accessed from the grant <a href="#">website</a> .
<b>December 31, 2020</b>	<b>Funds must be expensed.</b>	<b>Schools must expend distributed 2019-2020 Formative (Interim) Assessment Grant Funds by this date.</b>
