This annual event is a combined partnership between the Northern and Southern District of Indiana U.S. Attorney's Offices and the Indiana Criminal Justice Institute. We are dedicated to bringing you state of the art topics in law enforcement.

Keynote:

Major Roy E. Alston serves as a major with the Dallas, Texas, Police Department (DPD). He began his career with the DPD in August 2003, serving as a patrol officer. After completing his doctorate degree, Major Alston was assigned to the DPD In-Service Academy, where he was a training coordinator and a departmental expert in leadership development for law enforcement. While at the In-Service Academy, he developed the police officer's leadership development series. Major Alston has also served as a watch commander in the Communications Unit, overseeing the 9-1-1 Call Center and the Dispatch Center. Major Alston also served as the commander of the Bexar Street Satellite Police Station and was responsible for the Southeast Patrol Division's neighborhood police officers, the Dallas Housing Authority officers, the crime response teams, and the deployment teams. While serving as a sergeant, Major Alston served as a patrol supervisor in the Central Patrol Division.

Major Alston is the author of three leadership books, including *The Leader's Compass for Law Enforcement Professionals: A Values-Based Approach to Influencing People, Accomplishing Goals, and Improving Your Organization*. Major Alston served in the U.S. Army as a commissioned officer with the 82nd Airborne Division and served in combat with the 1st Battalion of the 319th Field Artillery Regiment during the first Gulf War. He is a graduate of the U.S. Army's Ranger School, the Airborne School, the Jungle School, the Field Artillery Officer's Basic Course, and the Field Artillery Officer's Advanced Course.

Major Alston earned his doctorate degree in management, with a specialization in leadership and organizational change, from Walden University in 2010 and earned his master of business administration degree from Indiana Wesleyan University in 2003. He is a 1989 graduate of the United States Military Academy at West Point, where he earned a bachelor's degree in leadership.

Important Information

This training is *free* to all Indiana state, county, and local law enforcement agencies. Two nights lodging (9/05 & 9/06) will be paid for Indiana state, county, or local law enforcement only (employees of the federal government or private corporations are not eligible). For lodging to be covered, the eligible attendees must live more than 50 miles one-way from the conference location. Attendees staying more than the designated 2 night's are responsible for the extra night's expense. Mileage and per diem will not be covered and are the attendees.

Lodging will be at the Indianapolis Marriott East, 7202 East 21st Street, Indianapolis, IN 46219. Lodging requests must be received by August 03, 2018 (The US Attorney's Office will make the reservations, cancellations and/or room assignments for preferred partners). Lodging cancellations must be made through the US Attorney's office no later than August 27 2018. Those who register and *do not* attend will be responsible for the lodging expense if not cancelled by the required deadlines.

IMPORTANT LODGING INFO-LODGING IS COVERED THROUGH A GRANT FROM THE INDIANA CRIMINAL JUSTICE INSTITUTE. EVERY YEAR WE HAVE A WAITING LIST FOR LODGING MEANING WE TURN OFFICERS AWAY FROM THE EVENT. THIS IS TYPICALLY BECAUSE SOME OFFICERS WILL SIGN UP AND CANCEL LAST MINUTE OR OFFICERS WILL BOOK A PARTNER THAT THEY KNOW WILL CANCEL IN AN EFFORT TO GET A SINGLE ROOM. IF, WHEN REGISTERING YOU BOOK LODGING, PLEASE MAKE SURE YOU ARE ATTENDING OR YOUR PARTNER IS ATTENDING. WE ARE TRYING TO KEEP AS MANY OFFICERS AS POSSIBLE SAFE THROUGH LAW ENFORCEMENT TRAINING, SO PLEASE BE FAIR TO A FELLOW BROTHER IN BLUE. FAILING TO FOLLOW THE LODGING INSTRUCTIONS COULD PROHIBIT YOU OR YOUR AGENCY FROM LODGING IN THE FUTURE.
